NOTICE IS HEREBY GIVEN that a special election has been called and will be held in and for Independent School District No. 203 (Hayfield Community Schools), State of Minnesota, on Monday, September 11, 2017, for the purpose of voting on the following questions:

School District Question 1

Approval of School District Bond Issue; Education and Infrastructure Improvements

- Yes** Shall the school board of Independent School District No. 203 (Hayfield Community Schools) be authorized to issue its general obligation school building bonds in an amount not to exceed \$9,990,000 to provide funds for the acquisition and betterment of school sites and facilities, including the renovation, repair, remodeling, retrofitting, upgrading, equipping and construction of improvements to various school district sites and facilities?

School District Question 2

Approval of School District Bond Issue; Security and Activities Improvements

- Yes** If School District Question 1 is approved, shall the school board of Independent School District No. 203 (Hayfield Community Schools) also be authorized to issue its general obligation school building bonds in an amount not to exceed \$4,265,000 to provide funds for the acquisition and betterment of school sites and facilities, including the construction of cafeteria and interior concession stand improvements; the completion of dedicated SACC and flex space for before and after school childcare; the resurfacing of the track; bituminous surface replacement; and the construction of secure main building entry improvements, safety and security improvements, and the remodeling of the district office?
